LETTER FROM THE PRESIDENT



DEAR FRIENDS and Colleagues of St. John's:

Thank you for taking the time to read our 2014 annual report in which we celebrate our 50th anniversary of uninterrupted service. It's certainly not a coincidence that our 50th anniversary coincides with the 50th anniversary of the federal War on Poverty, which gave birth to the community health center movement. For 50 years, St. John's has

been leading change through health, and we are honored that we've had the opportunity this year to provide healthcare through more than 185,000 patient visits.

There have been tremendous advances in our healthcare system with the roll-out of Obamacare. More than 8 million Americans who were previously uninsured now have private health insurance and several million more received Medicaid through the expansion created by the Affordable Care Act. The numbers of Americans without healthcare coverage has dropped dramatically as a result. St. John's has seen a 40% increase in patient volume in 2013 alone, as newly insured patients obtain health care services for the first time. At St. John's the number of our patients who have Medicaid or other health coverage doubled to more than 25,000 patients as a result of the Affordable Care Act.

While there is much to celebrate there are still millions of Americans who were not included in the Affordable Care Act because of immigration status or length of time in this country. In Los Angeles County, St. John's worked closely with community partners like One LA and the Community Clinic Association, Supervisor Mark Ridley-Thomas, the Board of Supervisors and the Department of Health Services to expand the My Health LA program – which passed the Board of Supervisors on September 23, 2014.

Now, more than 140,000 Angelinos will be able to enroll into My Health LA and will have health coverage regardless of immigration status. St. John's is honored to be the medical home for more than 28,000 individuals and families who will now be covered under this new program.

This creates a tremendous foundation for us to advance our role as an agent of social change – addressing the social determinants of health, supporting healthcare for the tens of thousands of unaccompanied minors fleeing violence and brutality in Central America, providing a living wage of \$15 an hour for every St. John's employee, expanding our services to the homeless with a state of the art mobile clinic, expanding our transgender health program, and continuing to grow by adding more sites and improving services.

Thank you for your support of our patients and our work. Join us in celebrating 50 years of leading change through health!

HISTORY OF ST. JOHN'S

Reverend Lawrence Carter presided as rector of St. John's Episcopal Church from 1958-1974. During his tenure, South Los Angeles evolved from an area of **affluence to one of extreme poverty**. A true social rights activist, Rev. Carter **advocated tirelessly** for resources to address the desperate socio-economic needs of the local community. At the same time, Dr. Les Holve, President of the Los Angeles Pediatric Society, had identified the lack of health care services for impoverished inner-city children as a high priority for action. He contacted Rev. Carter and, together with consultant **Marion Clevenger**, they founded a clinic at the church, putting together a staff of pediatricians

who would volunteer their Saturdays at the clinic. In July 1964, St. John's Well Child Clinic opened its doors to the neighborhood's children. Soon after establishment of the clinic, **Dr. Kenneth Williams**, Director of Hematology at Children's Hospital, came on board to serve as St. John's volunteer medical director. He held that position for over 30 years. The next few decades brought new advancements and challenges to the health care industry. The year after St. John's Well Child Clinic came to life, Medicaid was created by the **Social Security** Amendments of 1965, helping states provide medical coverage for low-income families, as well as the

blind, elderly, disabled, and pregnant women. The Title X Family Planning program was developed in order to provide comprehensive family planning and preventive health services, and the **1970s** saw contraceptives become available to unmarried women. However, the U.S. also saw the first confirmed cases of **AIDS**, and an influx of **immigrants and undocumented workers** who could not legally be provided with medical care, an estimated 3.2 million of whom were already residing in Los Angeles County by 1991. During the late **1980s and early 1990s**, the clinic struggled to adjust to the changing healthcare landscape. St. John's Episcopal



Church, which was under the strong leadership of **Rector Rev. Warner Traynham**, pumped substantial Church resources into sustaining the clinic. In **1993**, **Jim Mangia** joined St. John's Well Child Clinic as President and CEO, hired by Rev. Traynham and **Lynne Gillies**, who served as Board President for the clinic for over 20 years. A grant provided by the Parson's Foundation, led by program director **Wendy Garen**, provided the initial funding to hire a full-time CEO. Under Mangia's leadership, the clinic began to integrate into **the larger healthcare environment**, contracting to provide Medi-Cal and managed care and other government and private insurance and reimbursement

programs. In **1997**, St. John's expanded to serve adults, transforming into St. John's Well Child and Family Center. The California Endowment awarded a substantial grant to St. John's to hire its first full-time Medical Director later that year. In 1999, St. John's opened its second clinic site in Compton – at the former site of St. Martin's Episcopal Church. **The Compton clinic** was provided ever-expanding space and free rent for over 10 years by **Bishop Jon Bruno**, leader of the **Episcopal Diocese** of Los Angeles, until St. John's purchased the Compton property from the diocese in 2010. In 2000, St. John's qualified

as a federally qualified health center. It has since grown into a network of **thirteen clinic sites and two mobile units** spanning downtown, South Los Angeles and Compton. In addition to serving more than **55,000** individual patients, St. John's plays a major role in health advocacy, co-founding the **South LA Health and Human Rights Conference** and **Right to Health committees**, and launching **transgender** health services and homeless outreach programs. St. John's continues to embody the role of sanctuary from which it was built, and will continue to provide comprehensive care to patients of all ages, **regardless of ability to pay**, as long as is necessary.

THE SUCCESS OF OBAMACARE

MORE than 8 million uninsured Americans received private health coverage through state or federal insurance exchanges. Close to 5 million additional Americans received health coverage through eligibility for the Medicaid expansion. And more than 3 million young people were allowed to be added to their parent's insurance plan.

The percentage of Americans without health insurance dropped from 22% to just over 13% and now, almost 90% of Americans have affordable or free health coverage because of the **Affordable Care Act!**

At St. John's more than half of our adult patients qualified for either the Medicaid expansion or to purchase subsidized insurance on the state health exchange (Covered California). Our insured patient numbers grew from **12,000 to over 25,000** in the course of one year. Patients accessing care at St. John's grew by close to 40% in 2013-2014 – with more than **185,000** patient visits provided to close to **55,000** unduplicated patients.

EXPANDING ON OBAMACARE

WITH the tremendously successful roll-out of the Affordable Care Act, there was still a substantial population of Americans ineligible for health coverage: recent immigrants and the undocumented. St. John's has always provided healthcare to all, regardless of income or immigration status. Because of this mission and our commitment to the immigrant population, we serve a higher percentage of undocumented, uninsured patients than any community health center in Los Angeles County.

St. John's worked closely with **One LA** (a community based organization based in the faith community which engaged in massive enrollment of eligible patients into **Medi-Cal and other Obamacare insurance expansion programs**) to advocate for an expansion of the **My Health LA program** – a county-funded effort to provide healthcare services to the remaining uninsured in Los Angeles County. As a result of these efforts and a commitment to this program from the Board of Supervisors, the Board voted to initiate the My Health LA program on Tuesday, September 23, 2014. As a result, **more than 146,000** residents of LA County who are not covered under the Affordable Care Act will have access to primary, specialty and hospital care – anchored to a medical home at a federally qualified health center. In the first month of enrollment for this program, **St. John's enrolled over 10,000 patients**. We expect to enroll close to 30,000 at St. John's alone as we continue our commitment to serve immigrant communities in Los Angeles County.

As well, this program will provide healthcare services for the large number of **unaccompanied minors** who have fled to the United States in recent months to escape gang violence, brutality and death. **St. John's is leading a collaborative effort** in LA County to create a system of care for these child refugees and ensure legal representation, mental health and trauma care, case management, social support and a full range of healthcare services to these children and their families.

ST. JOHN'S RAISES ITS MINIMUM WAGE TO \$15 PER HOUR



IN March 2014, St. John's proposed a minimum \$15 per hour living wage for all unionized employees in contract negotiations with our frontline healthcare workers' union, SEIU Local 721. The pay increase will affect employees ranging from janitors to dental assistants to outreach workers, and will take effect starting in March 2015. **St. John's is leading the country in providing a living wage.** In June 2014, the Seattle City Council voted to raise the minimum wage to \$15 an hour by 2017, applicable to businesses employing more than 500 workers. The announced pay increase at St. John's also came four months after the Los Angeles County Federation of Labor estimated that 46 percent of workers **in Los Angeles, or 810,864 people, make less than \$15 an hour**, and six months after Governor Brown signed legislation to raise California's minimum wage by 25 percent, from \$8 an hour to \$10 an hour, by the start of 2016.

HOMELESS OUTREACH

MORE

homeless people – individuals and families - live in South Los Angeles than in any other part of the county. Homelessness is especially devastating for children, with potentially serious consequences for their physical and mental health. St. John's **Homeless Services Program** tailors its services and locations to meet the needs of homeless children and their families. In addition to medical, dental, and mental health services, **St. John's connects people to substance abuse counseling, housing and transportation assistance, case management and other support.** The program is located at our Washington High School-Based Health Center but these services are also delivered through a **mobile clinic van** that brings services directly to the streets and the shelters where homeless people gather.



TRANSGENDER PROGRAM

THE Transgender community is one of the most marginalized groups in South Los Angeles, where approximately 2,100 transgender people live. A host of challenges including **poverty, harassment, discrimination, and a lack of physicians trained** on trans-health issues, place transgender people at higher risk for cancer, mental illness, substance abuse, HIV, and other conditions. In keeping with its commitment to reach out to those who are most vulnerable, **St. John's welcomes all patients regardless of gender identity, sexual orientation, or presentation.** We are the only community health center in South Los Angeles that caters to the transgender population by providing comprehensive medical care in a **safe and welcoming environment where people are free to be themselves.**

CONTINUING TO MEET CLINIC GROWTH

ST. JOHN'S continues

to grow to meet the need of the communities we serve. In 2014, we added three new sites. In an historic partnership with **St. Francis Medical Center**, St. John's now operates the perinatal health and testing center on the grounds of the hospital in Lynwood. Through a community benefits agreement negotiated through the **UNIDAD coalition**, St. John's will operate the 12 room **Rev. Warner Traynham primary and specialty care health center** just south of downtown Los Angeles – in the Lorenzo housing development. And St. John's opened the first FQHC operated school based health center on a community college campus at **Los Angeles Trade Technical College in South Los Angeles.** Together, these health centers will serve more than **15,000** additional patients each year.

AUGUSTUS HAWKINS HIGH SCHOOL STUDENT HEALTH ADVOCACY

THROUGH a unique partnership with St. John's Well Child and Family Center, students at Augustus Hawkins High School's Community Health Advocates School have the opportunity to enroll in a three-semester health advocacy program, where students learn about civic engagement, health care, and policy changes affecting the health care system. During the 2013-2014 school year, a class of 42 students participated in the three-session program, facilitated by St. John's Director of Community Relations, Mario Chavez. **Students ran their own health and wellness campaigns**, and learned about the policies and enrollment options surrounding the Affordable Care Act. Students were also given the opportunity for a semester-long internship, and were placed at St. John's, the YMCA, Councilman Curren Price's office, the Boys and Girls Club, and United Way. **In a move toward advocacy**, the class joined the March for Immigration Reform, the Health and Human Rights Convening and Action, and called for a tax on banks to create a health care trust fund that would benefit city residents and help close the life expectancy gap among residents of Los Angeles. **In 2014, all participants completed their internship and 80% went on to pursue college.** The program equipped students with the knowledge and skills to be civic leaders and navigators of local health systems in South LA, to be experts in ACA program enrollment, to assist their families and peers and families with navigating the health care system, and to develop working relationships with local organizations in order to **help shape their community.**
