# One day this summer,

I arrived at the health center early to get some work done before the hustle and bustle of the day began. It was barely 7:00am, yet the weather was already extremely hot. As I pulled into the parking lot, I could see more than 100 people lined up outside, leaning against the building, holding babies, pushing wheel chairs - waiting to be the first for the walk-in slots reserved for patients each day. I greeted the patients as I approached the door and told them we'd be open soon. Clinic staff members were passing out water. Patients smiled and nodded, eager to receive the services for which they had come.

Another day in the life of St. John's Well Child and Family Center, another day in the life of South Los Angeles.

In 2014, St. John's provided medical, dental and behavioral health services to 223,000 patient visits in South Los Angeles. With 13 health center sites (6 of them school based), and two mobile clinic units, St. John's is, by far, the largest primary care provider in South LA, which includes the sprawling neighborhoods of downtown and south central Los Angeles, Compton, Willowbrook, Westmount, Paramount and Lynwood.

St. John's is more than a traditional community health center. We are part of the developing social fabric that is transforming the health and wellbeing of South Los Angeles residents. We organize,



advocate, mobilize and impact social policy. Day in and day out, we address the social determinants that affect our patients' health, from slum housing to gentrification and displacement, from employment to food security. Through a combination of our direct work, our many partnerships with other nonprofit institutions and elected officials, and the full implementation of Obamacare, we are beginning to see a new day in South LA. Our patients' health is improving; more and more people are enrolled into health insurance; more and more South LA residents are accessing healthcare services; and many more of our patients are engaged in advocating for social change that will impact all of our lives.

Join us in celebrating a "new day in South LA."

# School Based Health Centers | Putting health at the center of community

The largest school based healthcare provider in Los Angeles County, St. John's provided care to more than 10,000 individual students and thousands of neighbors and family members at our six school based health centers. Directly improving student health outcomes and impacting educational performance, school based health is developing as the epicenter of community improvement and transformation. Once again, St. John's is leading the way in expanding access and building innovative approaches to the delivery of healthcare services, in elementary schools, high schools and community colleges across South LA.






# My Health LA Universal Healthcare Access in LA County

Ensuring that every person who lives in Los Angeles County has access to healthcare services (primary care, pharmacy services, oral healthcare) - LA County developed the My Health LA program to provide care to the hundreds of thousands of LA residents not eligible for Obamacare because of immigration status or income level. St. John's, in partnership with One LA, brought 800 patients and residents to the LA County Board of Supervisors in May 2015 to advocate for expansion of the program. St. John's has enrolled over 21,000 individuals - a whopping 73% of all those enrolled in South Los Angeles and 20% of the entire county, ensuring that everyone - including undocumented immigrants - have a right to health.

















# Affordable HOUSING | Better Neighborhoods - Same Neighbors!

Gentrification is sweeping through Los Angeles County, displacing long-term low-income residents and creating a health and housing crisis of epic proportions. The city's homeless population is surging. St. John's believes that the lack of safe and affordable housing and the homelessness crisis demands action! St. John's became a federally designated provider of healthcare services to affordable housing residents and has brought healthcare to thousands of homeless individuals and families through two mobile clinics - which provide care at homeless shelters and homeless service organizations throughout downtown and south Los Angeles. And we operate two large health centers at the center of affordable housing developments - one in the Figueroa Corridor (in partnership with Esperanza Community Housing Corporation) and one in East Compton (in partnership with Abode Communities).

# Unaccompanied Minors | A system of care for our most vulnerable children

St. John's is on the frontlines in responding to an unprecedented humanitarian crisis. With support from The Weingart Foundation and a group of foundations convened by the California Community Foundation, St. John's became the lead agency in Los Angeles County in creating a comprehensive system of care for the thousands of unaccompanied minors who fled to the U.S. in the summer of 2014. We have taken direct action to provide care, advocate and win asylum for these children in need. Partnering with dozens of legal, social service and advocacy organizations, St. John's was a first responder to this crisis.





# Transgender Health

## **Empowerment, Advocacy and Service**

In 2013, St. John's made history by becoming the first and only community health center in South Los Angeles to offer a Transgender Health Program, starting with just nine patients and growing to over five hundred patients served today. We've created a Transgender Advisory Board, a transgender patient right to health committee, and the Trans\*Empower program for economic and professional development. St. John's provides a name and gender-change clinic, legal support and extensive case management services through transgender staff and leadership. St. John's published a white paper outlining the extent of discrimination against the trans community in healthcare services and access. In partnership and with direction from the trans community, we are pushing for empowerment of a population that has been disempowered for far too long.
